# Worthing Cat Welfare Trust Privacy Policy

#### **Privacy and Legal Statement**

This document sets out how we, Worthing Cat Welfare Trust, will use personal data. Please read this document in full with care as you agree to be bound by its terms. If you do not agree, please speak to a Trustee of our charity immediately. This policy shall be reviewed at least annually.

#### What Information We Collect and Why?

We collect and use personal information such as your name, address, telephone numbers, email address, as well as details about your home to allow us to provide our service to you.

The Data controllers under the Data Protection Act 1988 and General Data Protection Regulation for your personal data are Worthing Cat Welfare Trust.

#### What Do We Do With Your Data?

We will use the data provided by you to provide a service for re-homing you a cat, or if you re-home a cat to us, as well as if you are a helper of our charity in any other way such as a fosterer, or shop assistant. We may contact you either by letter, telephone, text or email in order to advise you of any information about your cat, membership policy with us, or any events we feel may be of interest. If you would like to unsubscribe from our mailing list please let us know.

Your details will be shared within our charity to all parties who will need to offer you a service (rehoming a cat, joining as a member) and will also be shared to HMRC if you gift aid any donations. Your personal information will not be shared with any other companies.

By accepting this policy you agree that we can process your personal data, including sensitive data about you. You understand that all personal data you give us must be accurate, and kindly inform us if your contact details change.

We will hold any personal data you provide securely in line with the requirements of the Data Protection Act 1998 and General Data Protection Regulation. To ensure that personal data is kept for no longer than necessary, Worthing Cat Welfare Trust will put in place an archiving policy for each area of our charity in which personal data is processed, and review this process annually.
